

CITY OF LAGRANGE
INTERRUPTIBLE NATURAL GAS SERVICE
Revised: July 1, 2021

AVAILABILITY:

Throughout the City's service area from existing lines of adequate capacity.

APPLICABILITY:

Applicable to any commercial user with the characteristics listed below for any purpose exclusive of resale and for service at any one location through one metering point from lines of adequate capacity:

1. Annual consumption of at least 500,000 therms per year; and
2. A load profile that in the opinion of the City is non-seasonal; and
3. An operational source of standby fuel such as propane or fuel oil.

Service under this schedule is dependent upon the City having natural gas supply and capacity in excess of the requirements of higher priority customers.

MONTHLY RATE:

Base Charge.....\$500.00
Distribution Charge.....@.....\$0.135 per therm

PURCHASED GAS ADJUSTMENT:

The amount calculated at the above rate will be increased under the provisions of the City's Purchased Gas Adjustment Schedule.

BTU ADJUSTMENT:

Gas volumes metered in hundreds of cubic feet shall be multiplied by the factor in the City's BTU Adjustment Schedule in order to determine the number of therms consumed for billing purposes. The measurement of gas volumes shall be adjusted to standard temperature and pressure.

UNAUTHORIZED USE OF GAS:

The City shall have the right at any time following one hour notice to interrupt or limit the quantity of gas it delivers to a customer under this rate schedule. If a customer refuses to honor said limitation notice, the customer shall pay an allocated share of any interstate pipeline penalties charged to the City, as determined by the City, in addition to the Delivery and Purchased Gas Adjustment charges for such gas. The payment of a penalty charge shall not, under any circumstances, be considered as giving the Customer the right to take unauthorized gas.

EMERGENCY GAS:

If a customer finds it impossible to continue operations on standby fuel because of some bona fide emergency during a limitation period, the City may at its sole discretion furnish emergency gas service upon request out of its storage or peak shaving facilities. The customer shall pay a premium for each therm delivered under emergency service calculated to recover the additional costs associated with delivery of this gas, and the City may discontinue this service at any time.

ALTERNATE FUEL DISCOUNT:

In the event a customer desires to burn an alternate fuel in lieu of natural gas, the City may at its sole discretion discount the Distribution Charge stated above. The customer must contact the City and provide adequate proof that the delivered price of the alternate fuel is less than the total monthly charge stated above and that natural gas consumption will definitely be reduced if a discount is not offered.

ROUND-UP:

Customers that do not notify the City of their desire to opt-out will have the total of their utility charges rounded up to the next whole dollar. The proceeds of this round-up will be used to assist low income customers pay their utility bills or as otherwise directed by the LaGrange City Council.

CONTINUITY OF SERVICE:

The City does not guarantee an uninterrupted or undisturbed supply of natural gas service. The City will not be responsible for any loss or damage resulting from the interruption or disturbance of service for any cause other than gross negligence of the City. The City will not be liable for any loss of profits or other consequential damages resulting from the use of service or any interruption or disturbance of service. The City shall not in any way be responsible for the transmission, use, or control of natural gas beyond the point of connection to the customer's premises.
